

**Dominion Station Dog Swim**

The **Dominion Station Pool** has officially “Gone to the Dogs”, for one day that is! On Monday, September 1, 2014, the Dominion Station Pool will open its doors to man’s best friend. The swim is scheduled from 7 p.m. – 8:30 p.m. Bring your favorite four-legged friend for a refreshing dip in the pool!

There is **no fee** for this event; however, we will be collecting money and supplies for a local dog rescue group. A **donation** is appreciated.

**Event Rules:**

1. Completed registration form required.
2. One dog per human owner, please.
3. All dogs must be current on all vaccinations. You must be able to provide proof, if requested.
4. Prior to entering the pool area, please walk your dog to help him / her excuse themselves. We would like to avoid accidents in the pool as much as possible.
5. Your dog may be released from the leash upon entering the pool deck area.
6. No children under the age of 16 are allowed without adult supervision.
7. Your dog must remain under your control at all times. If he / she acts aggressively, please wait until he / she calms down before unleashing. If the dog continues to act aggressively, you and your dog may be escorted from the event. You can be asked to leave at any time.
8. Help your dog into and out of the pool.
9. Be courteous to other guests and clean up your dog’s accidents. Poop stations and bags will be on hand.
10. Female dogs in season are not allowed.
11. No puppies under 6 months of age.
12. Do not bring dogs with health or skin conditions that may endanger others.
13. Humans may enter the pool to assist the dog, however the pool is for dog swimming during this event.
14. Outside food and drink (dog and human) is not allowed in the pool area.

**Release of Liability and Indemnification Agreement**

**Dog Swim at Dominion Station Pool**

I acknowledge that I voluntarily have applied to participate and use, with my dog(s), Dominion Station Pool (“the pool”) for the swimming event on Monday, September 1, 2014.

I understand that the act of unleashing my dog(s) and being physically present inside the pool area necessarily involves risks of injury to me, to other people, to my dog(s), and to other dogs. I understand these risks are entirely my responsibility. I expressly assume these risks. I am aware of the risks and hazards inherent upon entering the pool area and I choose to voluntarily enter the premises, knowing the conditions might become more hazardous and/or dangerous for myself and/or dog(s) and I voluntarily assume all such risks, loss, damages, or injury that may be sustained by entering the pool.

By signing this release of liability and using the pool, I hereby fully and forever release and discharge Dominion Station Homeowners Association, and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my use or intended use of the pool. I fully and forever release and discharge the Dominion Station Homeowners Association, and their employees and agents from any and all negligent acts and omissions in the same.

By signing this agreement I also agree to indemnify the Dominion Station Homeowners Association, and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, brought against any or all of such entities based on my use or intended use of the pool.

I have carefully read this release of liability and understand and fully agree with its contents.
